

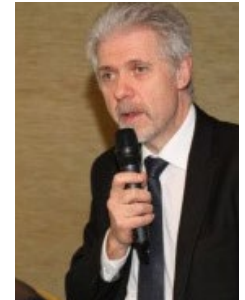


## IOTA IS A BOAT THAT WE SAIL TOGETHER - 25<sup>TH</sup> FORUM OF IOTA PRINCIPAL CONTACT PERSONS (PCPS)

This inclusive and interactive Forum was held in February in Antwerp, hosted by the Federal Public Service Finance of Belgium. The Forum serves as a platform for dialogue between the IOTA Secretariat and the 44 PCPs appointed in member tax administrations. PCPs are the bridge between the organisation and its members, playing a crucial role in the exchange of information, preparation and implementation of the work programme.

Mr Hans D'Hondt, President of the Executive Committee of Federal Public Service Finance of Belgium, welcomed the participants and spoke about the importance of IOTA in exchanging knowledge and experience and underlined the importance of member countries' engagement with the organisation. Together with his colleagues he also presented the findings of the IOTA Project on Measuring Debt Management Performance sponsored by Belgium.

## IOTA'S TAX ADMINISTRATION INFORMATION PLATFORM (TIP) BECAME AVAILABLE FOR OUR MEMBERS

IOTA's secure online data portal, the IOTA-TIP, which allows access and use of comparative data on 41 IOTA member tax administrations collected through the International Survey on Revenue Administration (ISORA), became available for IOTA member countries. The platform facilitates cross-country comparisons and analyses and enables participating IOTA member tax administrations to take high level management decisions to improve their tax administration and processes and find appropriate solutions for underperformance in particular areas.
